### WHAT IS KIDCOIN?

Kidcoin is a blockchain-based family finance platform that teaches kids how to value and manage money, while offering incentives for them to earn rewards for their contributions, achievements and good deeds.

Our vision is to raise the next generation of kids to be more fiscally responsible citizens, by managing their money proactively, minimizing debt wherever possible, and practicing healthy financial habits such as budgeting, goal-setting and reconciling their accounts periodically.

By engaging parents, family members and communities in the process, Kidcoin embraces an interactive, open architecture model, that is conducive to collaboration and in line with the saying - "It takes a village to raise a [financially savvy] child."

### HOW WILL KIDCOIN WORK?

The essence of life is in the details. Kidcoin will hone in on micro-efforts that correspond to positive daily actions - like taking out the garbage, going to soccer practice, or getting a better grade on a test. Micro-efforts garner micro-rewards, and micro-scholarships can be earned for micro-achievements or good deeds.

Sponsors — who can be anyone from parents and relatives to brands, nonprofits and institutional donors — will define a campaign's required tasks and conditions as well as the corresponding reward, all of which are recorded on the blockchain.

The platform and supporting ecosystem will then work to:

- 1 identify the most relevant users to participate,
- 2 confirm potential recipients' acceptance of terms,
- 3 verify uploaded proof of achievement, and
- 4 release funds when all requirements have been met.

Kidcoin will thereby be accumulated as a powerful currency that can either be stored or invested for future use, or utilized immediately to acquire products and services within Kidcoin's vetted, age-appropriate primary and secondary (P2P) digital marketplaces.

For businesses and nonprofits, Kidcoin will offer a new way to meaningfully engage with their target audience while enabling them to build brand loyalty and gather automated analytics that can help to inform their strategic decisions.

To make all of this possible, the Kidcoin ecosystem will be powered by Ethereum smart contracts and Hyperledger which will provide partners and auditors an easy way to integrate with Kidcoin.

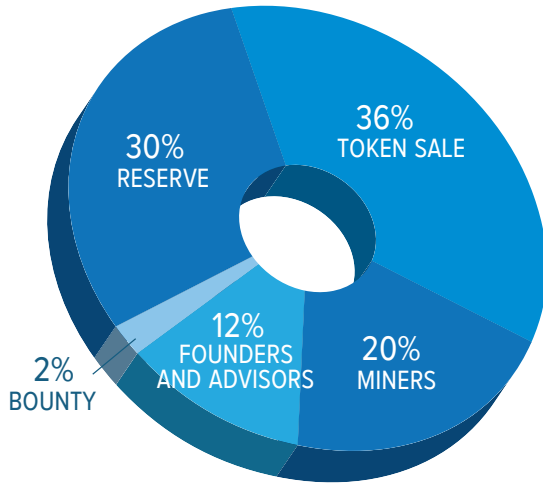

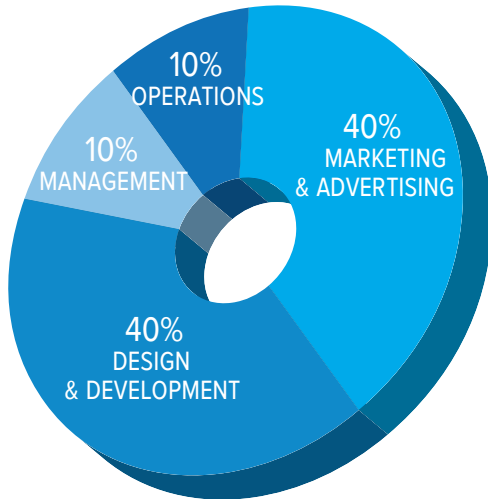
